- 9. (09) You will promptly and truthfully answer all inquiries directed to you by the court or the officer, and allow your officer to visit in your home, at your employment site or elsewhere, and you will comply with all instructions your officer may give you.
- 10. (10) You will pay restitution, court costs, and/or fees in accordance with special conditions imposed or in accordance with attached orders.
- 11. (12) You shall submit to the drawing of blood or other biological specimens as required by s. 943.325, Florida Statutes.
- 12. (13) You shall submit to the taking of a digitized photograph as required by s. 948.03, Florida Statutes.
- 13. (13a) You shall pay a related cost of \$1.00 for each month of your probationary term. The amount due, up to \$60.00, shall be paid within the first ninety (90) days after the beginning of your probationary sentence. Further, payments, if any, shall be paid in accordance with a schedule to be established by your officer, if the offender agrees, or the Court.
