On September 16, 2011, an email was received by Chief Inspector Cindy Sanz regarding possible misconduct on the part of FDLE Resident Agent in Charge (RAC) Robert Wayne Ivey. The email was titled from "VolusiaExposed.Com" a website and indicated a return email address of volusiaexposed@cfl.rr.com. On September 19, 2011, Special Agent Supervisor Scott McInerney was assigned to review the email received by Chief Sanz. In the email, the anonymous sender noted the following concerns related to FDLE Resident Agent in Charge (RAC) Wayne Ivey:

Ms. Sanz:

As indicated in the below email - you have been identified as the point of contact regarding information I have received regarding possible misconduct by FDLE Agent Robert Wayne Ivey.

First, allow me to clarify the following - I do not personally know Agent Ivey - nor do I have any first hand knowledge of his alleged miscenduct involving Ms. Osmanski.

Second, apparently FDLE is currently unaware of the alleged misconduct. (confirmed by Mr. Martin's below email)

VolusiaExposed.Com has received the following information:

FHP Trooper Robert Ivey and then Probation Officer Jessica Osmanski were engaged to be married. (confirmed in media articles)

Trooper Ivey is the son of FDLE Resident Agent In Charge (Brevard & Volusia County) Robert Wayne Ivey. (confirmed in media articles)

Trooper Ivey and Ms. Osmanski ended their engagement. (unconfirmed)

Trooper Ivey attempted to reclaim some items of property given to Ms.

Osmanski during their relationship wip to including a vehicle. (unconfirmed)

FDLE Agent Ivey contacted Ms. Osmanski apparently by telephone at her office within the Melbourne, Florida Probation and Parole office. (unconfirmed)

During the above phone conversation - FDLE Agent Ivey threatened Ms. Osmanski should she not return the property. (unconfirmed)

This telephone conversation was overheard by others staff members within the probation office. (unconfirmed at this time)

That a complaint was filed, possibly with FDLE, regarding Agent Ivey's above described alleged behavior. (unconfirmed)

Ms. Osmanski no longer is employed by the Probation and Parole office. (confirmed via telephone conversation with her ex-supervisor Officer Vanasse) (apparently Ms. Osmanski is now employed with the Hillsbourgh County Sheriff Department)

During my conversation with Officer Vanasse, he did confirm that Ms. Osmanski received such a phone call - but he declined to speak in particulars about the incident. Upon questioning - Officer Vanasse indicated that as far as he was aware no official documentation was generated on the incident, to include any emails generated by him. He considered the incident a personal matter. Officer Vanasse would surely cooperate with any official FDLE investigation into this matter.

Further - conveniently, both yourself and Ms. Osmanski are apparently located in the Tampa, Florida area - therefore, her interview by your office could be easily facilitated.

Volusiaexposed.Com anticipates the possibility of receiving supportive documentation in support of the above allegations.

I anticipate that FDLE will desire to investigate this matter as it did regarding the FDLE Agent Mike Taylor situation. (see attached media article)

On September 19, 2011, RAC Ivey submitted a letter of retirement, effective September 22, 2011. A copy of RAC Ivey's retirement letter will be attached to this preliminary review file. After a review of the email, it was determined that the noted concerns appear to be based on unconfirmed reports to an unidentified source using the name of an informational website, VolusiaExposed.Com. The information provided is not supported by any firsthand knowledge or evidence and no official complaint was received from the parties named. Additionally, RAC Ivey is no longer employed by FDLE. Therefore, no further investigation is warranted by FDLE.
