As you are aware, OUR publication (VolusiaExposed.Com) has in the past expressed concerns regarding Mrs. Allison Hughes' desires to secure a judicial appointment.

In short, we hold the opinion that she does not possess the ethical fortitude to hold a position of public trust.

Our concerns center on her failures to properly defend Ms. Nicole Jackson, a fourteen year-old girl, in what we believe was a "railroaded criminal prosecution" pushed by a tyrannical sheriff. We opine that Ms. Jackson's trial defense team (**including Mrs. Hughes**) worked hand-in-hand with the sheriff, the state attorney, and the judge to coerce a middle school child into taking a twenty year prison sentence (plea), solely to protect the sheriff from public ridicule, over false statements he had made against the child.
