NARRATIVE CONTINUED

It was discovered that due to the fire on 1 Burgundy Place, the fence of 2 Burrel Place was damaged. The damage was to at least eight (8) plastic, 6-inch fence sections. It should be noted that each fire that took place grew and were close homes.

Deputy Cowan stated she spoke with people who witnessed the fire on 1 Burgundy Place, Christawn Otis and Christopher Otis. Deputy Cowan stated that they both live on 19 Oxford Lane, Palm Coast, FL. Christawn and Christopher were driving to 3 Burgundy Place, when they saw a small stick on fire. Once they stopped, they saw large flames in the wooded lot of 1 Burgundy Place. Christawn and Christopher stated they saw a white, female, wearing a black hoodie and blue jeans coming out of the wooded area and walked away towards the higher numbers on Burbank Drive.

Deputy Cowan made contact with another witness who resides at 193 Birchwood Drive. Deputy Cowan spoke with Jose Clemente who allowed her to view the Nest Camera footage. Deputy Cowan's statement is as follows: "Viewed Nest camera to see female walk west on Big Dipper Lane, then north on Birchwood Drive. Female is seen walking into wooded lot of 1 Big Horn Drive. Female is then seen walking back out of wooded lot, walking east on Big Horn Drive, and then smoke is seen on video coming from 1 Big Horn Drive. Jose Clemente will be e-mailing video to Dep. Morgante."

It should be noted that N.J. resides at a group home located at 3 Burgundy Place. I spoke with Weeda Anderson via phone, the group home employee where N.J. resides at the moment. I advised Weeda of N.J.'s charges and Weeda stated she is in fear of her life that N.J. started a fire close to 3 Burgundy Place.

Deputy Cowan used the Flagler County Property Appraiser website to identify the property owners of the wooded lots that were burned. The sworn written statements that were collected from Christawn and Christopher Otis will be turned into records. The camera footage will be uploaded to LERMS when Jose sends it to me via my work email. My Taser Axon body camera was utilized and will be uploaded to Evidence.com

NJ intentionally burns, sets fire to, or causes to be burned or causes any fire to be set to, any wild land or vegetative land clearing debris not owned by, or in the lawful possession of, the person setting such fire or burning such lands or causing such fire to be set or lands to be burned without complying with s. 590.125
