The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 1st day of August, 2024, at approximately 10:15 hours at [REDACTED], violated the law and did then and there:

3. On August 1, 2024, at approximately 1021 hours, Lieutenant Teske responded to [REDACTED]
4. [REDACTED] in reference to the report of a physical fight between husband and wife. Upon arrival, Lieutenant
5. Teske made contact with Cody Cochran (D1), who stated the following:
- 6.
7. Cody stated he was in a verbal altercation with Theresa after she showed up unannounced and began
8. removing items, which he just purchased. Cody would not elaborate on any further details as to what
9. took place during the incident. Cody denied the incident ever got physical. Cody completed a sworn
10. written statement that said, "No statement at this time." Cody had slight redness above his right eye
11. and was profusely sweating.

13. Lieutenant Bello made contact with Jason Marceau (W1) who said he and Michael Papa (W2) were working
14. in the area when they heard a female screaming, Help! Help!" Jason and Michael went over to [REDACTED]
15. [REDACTED] to see if they were able to help the female who was screaming in distress. Jason and Michael
16. completed sworn written statements.
- 17.
18. Lieutenant Mills made contact with Miranda Cochran (O1) who said she heard Theresa frantically seaming
19. for help. Miranda did not witness the incident; she only heard it, as she lived directly across the
20. street from them. Miranda has no relation to Cody or Theresa, coincidentally just have the same last
21. name. The incident was heard on Miranda's home video system and was later emailed to Lieutenant Mills.

23. Deputy Kagle made contact with Theresa near the intersection of Freemark Street and Tug Hill Lane.
24. Theresa said she came to the residence to gather some belongings and allow Cody to visit with their
25. three children they have in common. While Theresa was gathering belongings, she observed Cody going
26. through her cell phone, so he did the same, which is what escalated the incident. Cody and Theresa
27. went back and forth going through each other's phone which upset them. Cody gave Theresa a "bear hug"
28. and bit her hair. Theresa told Cody she was going to leave, which caused Cody to strike himself in
29. the face. Theresa began screaming for help, so their daughter Kindahlyn Cochran (R1) called 911 for
30. assistance. Theresa was seated inside the vehicle, at which time Cody struck her in the face and grabbed
31. his cell phone. Theresa completed a sworn written statement, which only stated she did not wish to
32. pursue charges. Theresa swore to everything else, which was captured on Deputy Kagle's BWC. Theresa
33. had no visible injuries.

35. Deputy Kagle made contact with Kindahlyn who said she witnessed a portion of the incident after
36. she heard Theresa screaming. Kindahlyn heard the screaming from inside the residence, at which time
37. she went inside to check on the well-being of her mother. Kindahlyn observed Cody striking himself
38. in the face and was unable to tell if Cody was striking Theresa as well. Kindahlyn also observed Cody
39. strike Theresa in the face when she was seated inside their vehicle. After she witnessed this incident,
40. she called 911.

42. Cody was determined to be the primary aggressor and was placed under arrest for battery.
- 43.
44. Theresa was provided with a rights and remedies packet, which she signed for. Theresa also elected
45. Mary's Law and to keep her information private.
- 46.
47. Photographs were taken of both Cody and Theresa, which were later uploaded.
- 48.
49. It should be noted, Cody Cochran Jr (O2) and Alice Cochran (O3) were also present during the altercation
50. but did not witness anything. A copy of this report was sent to the Department of Children and Families
51. for review. Director Quann was also notified of the incident.

53. Cody was later transported to the Volusia County Branch Jail with no bond allowed.
