#### Incident Report # 230007461



On 9/19/23 at approximately 0900 I was contacted by State Attorney Investigator Gina Baker in reference to Inmate Jackson, Shane 1124583. She had concerns about privileged contact between Inmate Jackson and Attorney Michelle Bevilacqua. She stated that Bevilacqua was not the inmates' listed attorney but they were sending messages between one another under Private/Privileged communication through Smart Iail Mail, the communication service that Volusia County Corrections uses. I informed Investigator Baker that I would look into the matter.

I reviewed Inmate Jackson's Smart Communication account and viewed his messages where a majority of the inmate's communication come from Michelle Bevilacqua and are labeled Private/ Privileged Communication which is not viewable due to attorney client privilege. I then looked at their connection created on 6/16/23 with the inmate as a Professional relationship as a private attorney but not approved until 6/21/23. I contacted booking who sent me Inmate Jacksons attorney on file with the courts which is Michael Panella with the Panella law Firm. I reviewed the inmate's photo's section in Smart Jail Mail and on 6/19/23 and 6/20/23 photos were sent to Inmate Jackson account from Attorney Michelle Bevilacqua containing herself and the Inmate which appeared to look like more than an attorney client relationship. There are also near a hundred photos sent from Attorney Michelle Bevilacqua to Inmate Jackson that are privileged and cannot be seen.

I then reviewed ICSolutions which Volusia County Corrections of Inmate Jackson's phone calls. As I am reviewing his calls I observe a number that's called more than usual over 500 times since his incarceration on 6/19/23. When I clicked on the number to verify the account I observed the number is associated with an account set up by Attorney Michelle Bevilacqua. After listening to some of the recording you here conversations that start with "Hey Babe" from the attorney and Inmate Jackson as well as at the end of the phone calls "I love you" from both parties. I notified Captain Kisner of the information. I then went to Unit 10 to Lt. D'Esposito's office. I had Inmate Jackson escorted to the office where I interviewed the inmate regarding the concerns on video with Lt. D'Esposito present.

I told him I was there to ask a few questions and asked the inmate who his attorney for his case was? He stated "Michael Pannella."

I then asked the inmate if that is the only attorney on his case?

The inmate stated "Yes."

I asked the inmate if that's the only attorney on his case what is his connection to Michelle Bevilacqua? He stated "Oh she helps him from time to time with my case because hes out of Orlando."

I asked if their relationship was strictly professional?

He stated "Yes."

I stated "well we have access to phone calls that are made as all jail calls are recorded" and I questioned him about the pictures sent to him from Michelle Bevilacqua that painted a different picture of their relationship? He stated "Yes our relationship is more than professional, and we have been seeing each other since before I came back to jail."

I asked if their communication was in fact privileged when they communicate through her attorney privileges like the photos sent and the messages?

He stated "I can sign into my tablet and show you, there's nothing inappropriate."

I said if you want to sign into the tablet then he could it was up to him.

He signed in and stated "You can look at them."

After looking at the photos that were sent to Inmate Jackson from Attorney Michelle Bevilacqua that were marked "Private/Privilege" is was 13 pages of pictures of herself posing in many different positions but never explicit photos. Most of the photos were not in any way case related nor did they meet the attorney client privilege standard and appeared to more a misuse of the Michelle Bevilacqua practice as an Attorney to circumvent the system so her information sent could not be viewed by any one.

I then looked at Attorney Michelle Bevilacqua's visit history in the Beacon Data Base that the Division uses. The attorney has had 8 contact visits with Inmate Jackson while he has been incarcerated. These visits ranged from 3-5 hours at length at the control room. The visit from 8/25/23 and 9/10/23 are still in the Ocularis system and can be viewed.
